

A MESSAGE FROM YOUR LV PRESIDENT

I hope you all have relief from your weather woes. Here in the Northeast it hasn't been too bad, just way hotter than it should be this time of year. Not great weather for training!

The biggest news I have for you this issue deals with scorebook processing. We are returning to the system we had years ago – you can apply directly to Germany for scorebooks. That will save you several days in getting your scorebook. You can read all the details in this issue starting on page 10 and on the website at www.DVG-America.com/membership.html. You will still pay the LV for the scorebook, and we will pay Germany. You can pay either on-line or by check. Please pay for your scorebook when you order it, or we will have to bill your club! Additionally, a change has been made concerning the application process for new members, please make sure to check the website for full details!

Arrangements for the Nationals are coming along. The website has been live for some time; you can find it at www.DVG-America.com/2015lvchampionship/index.html.

Note that the competition field is under a roof (it's not indoors) so we don't need to be concerned about rain or snow – except for tracking. There's a picture on the Nationals website.

You will be able to register for the Nationals online. Online registration will open August 1st, site address is: www.DVG-America.com/2015lvchampionship/entry.html
The judges are set, and we are getting two judges from Germany this year. The Chief Judge, Klaus-Jürgen Glüh, will be judging protection. The OfS from Germany, Volker Sulimma, will judge obedience. Ted Hartman will judge tracking. The Chief Judge will be talking to our judges about all the rule changes we can look forward to in 2016. I know we all can't wait for that!

For those of you interested in attending the BSP, it will be later than normal next year. Currently the dates are May 20-22, 2016.

Annual renewal time is almost upon us. Unlike previous years, we are not asking for forms for every member, or for rosters. We do need to know if you have new members, or members who are dropping out. You don't need to calculate your own dues; we will send your club a bill for your dues, based on the information we have about your club in the LV's database. Please help us make sure that information is correct.

Amanda Hoskinson to attend to act as team captains for our LV team. Michael Conley was unable to compete after arriving in







DVG MEMBERSHIP 101

THIS ARTICLE WILL BE THE FIRST IN A SERIES WHICH WILL EXPLAIN THE NEW MEMBERSHIP APPLICATION AND RENEWAL PROCESS FOR LV DVG AMERICA

Over this last year, work has been done to streamline both new member applications and existing member renewals; automating as much as our organization's club system will allow. In addition, verifying alignment with German membership levels was also completed. The topic of this first article is the new Membership Levels which are effective immediately.

A Bit of History:

Because of the way that Germany identifies families, we have made slight adjustments allowing clearer identification of family and household relationships. The abbreviations our LV will be using for each membership level are now closer to the DVG Germany abbreviations. This allows LV DVG America to compare our membership rosters with those of DVG Germany, verifying our dues payments are accurate and correct.

Part of this streamlining required clarification of membership levels. In the past various membership levels were offered with options (for example: with, or without a subscription). These clarifications mean that there

DVG SCOREBOOKS: WHAT YOU NEED TO KNOW!

A PRIMER ON THE BENEFITS AND PROCESSES OF APPLYING FOR A DVG SCOREBOOK.

DVG Score Book Information

As a DVG member you are eligible to apply for and receive a DVG scorebook. Only DVG members may apply for, and only current DVG members may use these books at trials, no matter what the sanctioning body. To receive certain benefits a member MUST use their DVG scorebook.

When trialing at a DVG sanctioned event, one enters as either a DVG member, or as a guest. Entering as a DVG member requires both a DVG score book for the dog and a current DVG membership card for the handler.

What are the benefits of trialing with a DVG score book?

Some of the benefits of trialing as a DVG member with a DVG score book are:

- You earn awards and points when trialing as a member.
- Trial results are recorded by DVG and recognized internationally.
- Scores earned qualify you and your dog for events such as the annual LV IPO Championship where we select participants for the championship in Germany.
- You can trial at a KG or LV Championships.

What if I'm a DVG member but I don't use a DVG scorebook?

If you have more than one scorebook, DVG judges will fill them all out. But if you use only a non-DVG issued scorebook, then you must trial as a guest. When trialing as a guest, DVG club benefits not only do not accrue, but

trial results may not fulfill prerequisites for other events such as the LV Championship.

What is a scorebook?

A scorebook is a physical record of all of the dog's trial performances and belongs to the dog. If a dog's ownership is transferred, the book ought to go with the dog. Refer to the FAQs for how to make changes to the scorebook.

What information is on a scorebook?

The owner's information on a dog's book ought to match the information on their DVG membership card. It is the owner's responsibility to keep the information on both of these documents, the dog's scorebook and the member's membership card, current.

Information about the dog's ownership is also included on the scorebook. As only DVG members can apply for books, the dog's owner must be a DVG member. Membership information can be found on the DVG America website at: www.dvg-america.com/membership.html

How do I order a DVG Scorebook?

You must do three steps to order your dog's book:

- Fill out the scorebook application form electronically
- E-mail (fastest, cheapest and preferred) or snail mail the application to Germany
- 3) Pay for your book

Step 1. Filling out the application

No matter how you send the completed scorebook application, Germany expects it to be filled in electronically. Hand written forms are subject to errors and are difficult for DVG Germany to interpret. Therefore, ALL applications ought to be filled out electronically. You can find the fillable form on the DVG America website at: www.dvg-america.com/DVGAmericaScorebo okApplication.pdf

Save this form on your computer. Once the form is filled out, save it again, using your dog's name along with your DVG membership number (for example: Fido ######). Then print out a copy and have your club president review the information to assure the form is filled out correctly, sign and date it.

By signing a scorebook application the club president confirms:

 Information relating to the dog in correct, such as the tattoo and registration.

- The dog on the scorebook application is the one in training, and will be trialed.
- The member is in compliance with both club and KG by-laws.
- The handler/dog team is preparing to show at a trial.

Once the club president (or the club's assigned representative) has signed off, determine if you will email the application or snail mail it to Germany.

Step 2. Sending the application

Step 3. Pay for your application

There are two different ways to pay.

We prefer that you use the link on the DVG America website to pay for your scorebook online.

If you would rather send a check by snail mail, then you will need to have an additional copy of your application to include. Mail both your check and a copy of your score book application to:

is now only one version of each membership level, with certain fixed requirements that will be discussed in more detail below.

Membership Levels are now named as follows:

Member (VM), Spouse/Partner, added to Member (P), Additional Adult same household, added to Member (VM), Child, added to Member (K) and Youth (JGDL).

Membership Level Criteria

Membership Level	Abbreviation	Magazine Subscription
Member (19 yrs+)	VM	Yes
Additional Adult (19 yrs+) In same household as Member	VM	No
Spouse/Partner of Member	Р	No
Child (18 yrs or under) tied to a Member	K	No
Youth Member (14-18 yrs)	JGDL	Yes

The Stand Alone Membership Levels

The two stand alone membership levels are "Member", and "Youth". Both include the magazine. The two levels differ in age and cost; with the Youth receiving a significant discount. This is to encourage more Youth members in our organization, a hallmark of DVG Germany.

Note that term "Member" is used rather than the old term "Full Member" because all LV Members have the same rights, privileges and responsibilities; no matter what the level.

What Does "Added to Member" mean?

These are Membership Levels that are linked to an existing Member. Any or all of these three additional memberships must be added to a current Member. These additional memberships together allow our LV to form family groups or groups, providing a discount similar to DVG Germany. These additional membership levels are:

Spouse/Partner, added to Member Additional Adult same household, added to Member Child, added to Member

"Spouse" has been expanded to allow for "Partner" in alignment with DVG Germany. The membership level implies a relationship between the Member and the Spouse/Partner.

"Additional Adult same household" is a re-naming of a version of the old "Full Member without a Magazine (2nd adult same household)". The intention was to allow a second adult in the same household to join and exclude the subscription since one magazine already comes into the household. However, this Full Member option was confusing as some thought that a Full Member could opt out of the magazine no matter what their living situation. By renaming this option it is clarified that it is only available to someone residing with an already existing member. This Membership Level is unique to our LV.

Finally, the "Child" category was added to make it clear that children, that are part of a family where one adult is a member, would be added to an existing member without a subscription. In addition, the Child category aligns more closely with DVG Germany.
